

With further reference to your letter of 20th ultimo, I have read carefully the Leaflet (enclosed with your letter) issued by the Bureau.

Briefly, my association with the I. R. B. commenced in 1900 and terminated in 1912. It is true that during the period covered by these years, I came in contact with most of the then Leaders and prominent members of that Organisation. I resigned my membership thereof in 1912, but as a statement of my reasons for doing so would necessitate bringing in the names of some of my esteemed colleagues, long since dead, but whose families are still living, I do not feel myself at liberty to discuss the matters involved. In my opinion this would serve no useful purpose.

As regards the Irish Volunteers, when 'E Company' was formed in 1914 at Rathfarnham, where I then resided, I became a member, fought with Commandant Pearse in the Post Office in 1916, was deported, first to Stafford Jail and subsequently to Frongoch, was released in due course and continued my membership of the Irish Volunteers up to the Civil War.

In the circumstances stated, I regret that, having given the matter very careful consideration, I am not in a position to supply your Bureau with more satisfactory information relative to my connection with these two Organisations.

The Bureau of Military History, 1913-21, was set up by the Minister for Defence on the 1st January, 1947, with the following terms of reference:—

"To assemble and co-ordinate material to form the

"basis for the compilation of the history of the move-

"ment for Independence from the formation of the

"Irish Volunteers on 25th November, 1913, to the

"11th July, 1921."

It is not the function of the Bureau to write the Military History of the period; its purpose is to assemble and collate in an objective manner the material from which

that history can be written, to ensure that that material is as accurate and comprehensive as possible, and, as part of that task, to collect and preserve what remains of original documents associated with the armed struggle for Independence.

To do its work effectively, the Bureau needs the fullest co-operation, particularly from those who, by reason of their position or personal contact with the events or personalities of the period, are in a position to give information on the many unrecorded aspects of the struggle.

Because of the circumstances of the time, and of the conditions under which the military organisations operated, the amount of original documentary material was of necessity very restricted, and, unfortunately, some of it has since been lost, through destruction, deterioration, or other causes.

The location, assembly, recording and preservation of such original documents as now remain are, therefore, matters of great importance. No original document, which relates to the struggle should be destroyed or allowed to deteriorate, even if it appears to be of trivial or purely local interest. The Bureau will gladly accept all such original documents presented to it, and will take steps for their safe custody and preservation for the nation. If the donor wishes to have copies made for him the Bureau will supply them.

Where a person having custody of original documents does not wish to present them to the Bureau, the Bureau would appreciate information as to their nature and contents, and would like to have permission to have them copied by photographic or other processes. Where documents are of such a nature that, while their preservation is historically important, the owner feels it desirable to impose conditions as to access to their contents, whether by way of time limit or otherwise, the Bureau will readily undertake compliance with any such conditions, and will arrange for the confidential custody of the documents accordingly.

If, in any case, the owner would prefer that certain documents should not pass for a specified time from his personal custody, or from the custody of persons nominated by him, but intends ultimately to make them available to the nation, it would be appreciated if the Bureau could be given a general indication of their nature or contents, and of the owner's intentions regarding them, so that a record may be made of their existence, and of their present and ultimate location.

able documents do not represent a complete picture of the events to which they relate, and for that reason much of the work of the Bureau will, of necessity, be concerned with the assembling of evidence, oral or written, from persons or bodies having first hand information of any phase or aspect of the conflict, whether in Ireland or abroad. The Bureau will welcome communications in writing from those who feel that they can assist in this way, and would ask them to give an indication of the areas, periods or phases upon which they are in a position to give information.

At the moment the Bureau is concentrating on the events which led to the formation of the Irish Volunteers and of associated organisations, and to subsequent developments up to the Rising of Easter Week, 1916, and it is to persons with a special knowledge of that period that this initial appeal for co-operation is being made. The Bureau will be grateful, of course, for assistance on any phase of its work, but would like to deal first with the earlier period mentioned. Later it will welcome co-operation in connection with the Rising itself and with the events of 1917-21.
